

End user license agreement

This end user license agreement (“Agreement”) is a legal agreement between you (either on behalf of yourself as an individual or on behalf of some other person including a body corporate as its authorised representative) and PharmaLex Ireland.

By checking the Agreement checkbox and downloading, installing, copying or otherwise using PharmaLex Ireland information/documentation you agree to be bound by all of the terms of this Agreement. If you do not agree to the terms of this agreement, click on the “Cancel” button and/or do not download, install, copy or otherwise use the software.

1) Defined Terms

As used in this Agreement, the term “Documentation” refers to PharmaLex Ireland Documentation which you have selected to download. It also refers to works that are created and fixed in print, electronic, fax, cd-rom, and other formats, including electronic mail, now known or developed hereafter.
